14. The surplus funds of the trust which has not been spent in any year shall be invested in the modes described under relevant sections of the Income Tax Act, 1961 as amended from time to time.

15. The Trustees shall at their discretion acquire purchase or sell immovable properties or movable properties in the course of managing of trust. However any sale of any sale of immovable shall require consent of at least three fourth majority of the trustees.

16. No income of the trust shall be applied for the personal benefits either of the Trustees or of the settlor.

17. The event of dissolution or binding upon the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Member of the managing Committee /Members of the Governing Body,

18. No amendments violating the Income Tax provisions to the terms of this deed Shall be made out obtaining the prior written permission of the Commissioner of Income Tax. However the ammenmands not violating the provision of the Income Tax Act 1961 may be made with the approval of board of trustees the Trustees in interest of achieving the objects of the Trust.

19. The Objects of the Trust shall be achieved without involving any activity for profit.

20. The Trustees and the members of their family shall not be entitled to the benefits of the Trust.

21. The Trust formed is irrevocable.

22. The funds/income of the Trust shall be solely utilized for achieving the objects of the Trust and no portion of it shall be utilized for the benefit of the Trustees by way of interest, bonus, divident, profit etc.

23. The benefits of the trust shall be open to all Indians irrespective of caste creed or religion.

- 24. To work for medical health awareness, environmental awareness and population control.
- 25. To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading rooms, universities, laboratories, research and other institutions having conformity with the object and nature of the trust, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.
- 26. To provide training to teachers, in order to equip them with the modern methods in pedagogy; and to organize teacher training units in different parts of India.
- 27. To borrow, raise loans from any person, bank and financial institution in such a manner as the Trustees shall think proper or convenient for the furtherance of the objects of the trust, and for this purpose the Trustees may secure repayment of these loans in any manner as may be decided for time to time.
- 28. The accounts of the trust shall be regularly maintained and audited by the Chartered Accountant per year. The accounting year for the Trust shall be from 1st April to 31st March each year.
